Re: February 28th Coordinating Council Advisory Committee Meeting Information

This memo provides a brief overview of the Coordinating Council Advisory Committee (CCAC) meeting on Wednesday, February 28th from 3:00-4:00 p.m. at ICJIA's office at 300 West Adams, Chicago, Suite 200. We look forward to your participation.

First, we want to begin with a discussion of this Committee's charge: to review and advise on the Authority's efforts to encourage coordination and cooperation between the State and local agencies on criminal justice planning in order to improve the safety of all the people of Illinois in the most effective and cost-efficient way. This includes our work with Criminal Justice Coordinating Councils, Family Violence Coordinating Councils, Juvenile Justice Councils, Adult Redeploy, and similar local and regional collaborative groups.

Next, to kick off this effort, we will present an overview of the scope of local coordinated criminal justice activities in Illinois with which ICJIA is involved. The presentation will explain the purpose and goals of each group, map where they are currently active throughout the state, and provide list of each group and their main contacts. Then we want to get your insights about the current mandates and design of these groups and how the Authority can best coordinate and use its resources to support the success of these efforts.

Finally, we would like to discuss your reaction to the results of a survey of our criminal justice coordinating council sites (Lake, McHenry, McLean, St. Clair, and Winnebago counties), which solicited input on the trainings and sessions to be held at our spring workshop for the councils. The workshop will be hosted at Loyola University later this spring. More information about the workshop will be announced as details are confirmed.
